Purpose of processing

In principle, we only process the data received from you for the purposes for which we receive and collect it. This may concern the following purposes:

- Execution of communication
- Answers to requests
- Preparation and execution of services
- Preparation and settlement of contracts

In case of processing for other purposes, we adhere to the guidelines of art. 6 paragraph 4 of the AVG, which means that we are bound by very strict requirements with regard to safeguarding your privacy and that you will be informed about this.

Legal basis for the processing

The legal basis for the processing of personal data is Art. 6 of the AVG (see the text of this article below).

Article 6 - Lawfulness of processing

1. Processing is lawful only if and to the extent that at least one of the following conditions is met:

- a) the data subject has consented to the processing of his personal data for one or more specific purposes;
- b) the processing is necessary for the performance of a contract to which the data subject is a party, or for action to be taken at the request of the data subject before the conclusion of a contract;
- c) the processing is necessary to comply with a legal obligation of the processor;
- d) the processing is necessary to protect the vital interests of the data subject or of the interests of another natural person;

e) the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority entrusted to the processor;

f) processing is necessary for the protection of the legitimate interests of the processor or of a third party, except where the interests or fundamental rights and freedoms of the data subject which require the protection of personal data outweigh those interests, in particular when the data subject is a child. The first paragraph of point (f) does not apply to processing by public authorities in the performance of their duties.

You have the right to withdraw your consent at any time.

According to art. 6 paragraph 1 letter (f) of the AVG (a balancing of interests), you as a data subject have the right to withdraw processing of the personal data.

Data transfer to third parties and outside the EU

In principle, your data will only be passed on to third parties:

- if this is necessary for the execution of the agreement with you,
- transfer, based on a balance of interests within the meaning of art. 6 paragraph 1 letter (f) of the AVG is permitted by the AVG,
- if we are legally obliged to pass it on or if you have given us permission to do so.

If the transfer of data to another country outside the EU takes place, an appropriate level of data protection is ensured through the conclusion of EU standard clauses and / or the recipient's participation in the so-called "Privacy Shield" to ensure that third parties protect the privacy and security of your data appropriate measures are guaranteed.

Storage period

The personal data is stored by the processor for as long as it is necessary for the purpose of the processing. If and insofar as the storage of data is no longer necessary, it will be deleted. On request we will inform you in writing or electronically about your personal data that we have stored.
