#### Tank rental services

REYM has over 400 certified offshore tanks, suitable to store and transport different kinds of chemicals and waste streams. The REYM rental fleet consists of tanks with a capacity of 2.5 m³, 4.5 m³, 7 m³, 8 m³ and 20 m³ and drill cuttings containers of 3.7 m³ and 7 m³, all certified in accordance with EN 12079, DNV 2.7-1 and Lloyds.

All tanks are available for long or short-term rental periods.

## **Transportation**

Using an extensive and modern fleet, REYM is able to safely transport dry substances, sewage sludge, fluids and hazardous waste. REYM chooses the appropriate means of transportation you need for your specific waste material. All our transportation equipment meets the highest environmental standards and the ADR and EU directives.

At CMP, REYM produces all types of drilling mud production fluids imaginable for the oil and gas industry.
